SECTION 3.6, VOTING,

At a National meeting duly called and held, the NGB members and the official proxies who are in attendance shall decide any agenda items presented by majority vote of the quorum unless otherwise provided for by these Bylaws. Only one vote may be cast by each person.

Add: Honorary awards shall be voted on by the NGB a week prior to the NGB meeting via a secure polling system selected by the secretary of USA Powerlifting.

Rational: Honorary Awards take a large amount of time of the NGB's annual meeting. The organization would be better served to allow the full NGB the ability to review nominations and resumes of nominees.
